Renewal Payment via e-transfer (e.g. Interac and email)*

1. Complete and sign one-page Membership Form.
2. If not already registered with your financial institution, complete the registration.
3. **To E-Pay PROBUS**, select “manage recipients” and enter **Treasurer** and the e-mail address: **nwbprobus915@gmail.com**.
4. This will be an auto-deposit – therefore no security question is necessary.
5. Enter the payment amount **(ex. \$40, \$55, \$80 or \$95)** **and** in the message or similar box, enter “Northwest Bay PROBUS Club Annual Dues” and your name(s).
6. Email the signed and scanned Membership Form along with an **e-payment confirmation** [**Do not send E pay**] to **David Stevens, Membership Chair: dstevens216@gmail.com**
